When a 33 holiday falls on a Sunday, the following Monday will be the holiday. 34 35 All other terms and provisions of the current 2021-24 Agreement shall be unchanged, and 36 shall remain in full force and effect through June 30, 2025. 37 38 Effective July 1, 2024, employees subject to this Agreement shall receive a three percent 39
