As you skim the rest of the text, pay attention to the opening paragraphs, dialogue, subheadings, and words that you have never seen or heard before. Define those words the margins here.  Your preview will save you time when it comes to analyzing the text later on. When you	
are finished previewing the text, answer the following questions:	
Look up the author on Google. Summarize what you learned about the author from Google. What evidence do you see that tells you this is a credible writer? Biographical notes?

This should not focus on listing small details, or covering all of the plot points, but should cover the **main ideas** so that a student who did not read the novel would understand the gist, the purpose, and any other larger meaning the author(s) intended.

Finally, condense your **summary** into one clear **thesis statement** (try to do this in just one or two sentences) that explains the purpose of the text.
