

**Articulation Agreement**  
**Community Colleges of Spokane**  
**Spokane Community College (SCC) and Spokane Falls Community College (SFCC)**  
**Business transfer map (AA-DTA)**  
**Eastern Washington University (EWU) School of Business**

**Purpose**

This articulation agreement is for students who have earned an AA-DTA from Community Colleges of Spokane (CCS) inclusive of specific coursework identified in this agreement and will complete course work at Eastern Washington University to earn a bachelor's degree from the School of Business.

Completion of the AA-DTA will satisfy lower division graduation requirements consistent with the current policies of EWU. Students completing the course work listed below at Spokane Community College (SCC) or Spokane Falls Community College (SFCC) within an AA-DTA credential will have satisfied the identified equivalent EWU Business Core requirements.

**Duration**

This agreement shall begin the first day of September 2024 and extend until the last day of June 2026. The agreement will be reviewed at the end of this period and every 2 years thereafter to include possible revisions to the EWU requirements. Either school may discontinue this agreement by providing written notice to the other party 180 days prior to the date of discontinuation. However, if this agreement is discontinued by either school, EWU will continue to honor the terms of this agreement for students who meet all of the following requirements:

- The student has begun the AA track at CCS prior to the notice of discontinuation.
- The student is on schedule and does graduate from CCS in two years or less.
- The student has identified EWU as a transfer destination.

**Articulation Review**

Both SCC/SFCC's Business programs and EWU's Business program will designate a minimum of one faculty member per program to oversee articulation currency, accuracy, and efficiency. The appropriate representatives of SCC/SFCC and EWU shall review this agreement at the completion of each academic year. Amendments may be required and are allowed to maintain a functional relationship of the articulation agreement.

### **Business Degrees at Eastern Washington University**

Eastern Washington University has the following eight Bachelor of Science in Business Administration majors:

- BSB in Entrepreneurship
- BSB in Finance
- BSB in Human Resource Management
- BSB in Information Systems & Business Analytics
- BSB in International Business
- BSB in Management
- BSB in Marketing
- BSB in Professional Accounting

In addition, to earn a bachelor's degree, undergraduate students at EWU must satisfy general education requirements and graduation requirements that include a minimum of 180 quarter credits, 60 quarter credits taken at the upper division level and a minimum of 45 credits taken in residence at EWU. ### **Admission & Eligibility**

To participate in this agreement, students must

- Complete the AA-DTA with Business Map in good academic standing (2.0 or higher cumulative GPA)
- Meet all EWU application deadlines and admissions requirements
- Declare their Business major at EWU

Substitution of any coursework for the AA-DTA with Business Map must be approved in advance by the EWU credit evaluation team to remain eligible for this program. Evaluation of courses for transfer credit will not be bound by the terms of this agreement for students who choose to pursue a degree other than a School of Business degree. Course work for students who do not earn the AA-DTA and/or who choose to pursue a degree other than a School of Business degree will be evaluated in accordance with EWU Transfer policy.

### **Agreement Guidelines**

The following identifies SCC/SFCC coursework fulfilling the AA-requirements, noting equivalencies with EWU courses. The average grade in Business Core courses (indicated by an asterisk\* in the chart below) must be a minimum grade of 2.5 and with no grade below 2.0.
