FLATHEAD VALLEY COMMUNITY COLLEGE THEATRE ARTS PROGRAM AND EASTERN WASHINGTON UNIVERSITY'S BACHELOR OF ARTS TRANSFER

Articulation Agreement

Purpose

This articulation agreement is established between Flathead Valley Community College (FVCC) and Eastern Washington University (EWU) to facilitate the seamless transfer of students from the Theatre Arts program at FVCC to the Bachelor of Arts in Theatre at EWU. The agreement ensures clarity in course equivalencies, shared advising responsibilities, and degree completion requirements.

Terms

Shared Advising Responsibilities: Faculty and staff from both institutions will work collaboratively to provide students with comprehensive advising support. This will include guidance on transfer requirements, course planning, and degree completion strategies.

Materials Developed Jointly: Both institutions will jointly develop and maintain advising guides, transfer checklists, and other materials to facilitate the transfer process.

Start Date: This agreement takes effect on February 1, 2025.

Maintenance

Both FVCC and EWU programs will designate a minimum of one faculty member per program to oversee articulation currency, accuracy, and efficiency. The appropriate representatives of FVCC and EWU shall review this agreement at the completion of each academic year. Amendments may be required and are allowed to maintain a functional relationship of the articulation agreement.

First Review Date: September 30, 2027

Termination Date: This agreement will remain in effect until June 30, 2029.

Amendments and Notifications: Any amendments must be communicated in writing and

agreed upon by both parties with at least 3 months notice.

Provisos

Benefits for Students: Students completing the Theatre Arts program at FVCC will be supported to complete their Bachelor of Arts in Theatre at EWU within two years of transfer.

Conditions for Credit Transfer:

 Completion Requirements: Students must meet all FVCC requirements for the associate degree and EWU admission requirements.

- Course Fulfillment: The courses listed in the equivalency table below will fulfill requirements for the specified degrees.
- Application Requirements: Students must apply to EWU and meet all admission requirements in addition to fulfilling the associate's degree requirements.
- Remaining Bachelor's Degree Requirements: Students will need to complete the EWU Theatre Core curriculum, electives, and all degree requirements not met by transfer credits, including a total of 60 upper-division credits.

Coursework at Flathead Valley Community College:

The FVCC Theatre Arts Transfer Track associates degree satisfies all lower-division general education at EWU.
