MY EXPERIENCES

Vice President for Finance, Administration & Government Relations at New Mexico Highlands University, October 2013 to July 2022

As an executive leader, I held a pivotal role in finance, administration, and government relations at a prestigious institution of higher education. During my tenure, I deftly navigated a wide range of external challenges, including crisis management, natural disasters, financial downturns, governmental policies, and strategic planning with colleagues and other senior executives. My unwavering commitment ensured that the institution maintained an impeccable reputation and provided students with a top-notch education. I spearheaded developing and implementing policies that supported the institution's strategic goals. With the responsibility of projecting, implementing, and managing a \$127 million budget, I provided steadfast leadership for the institution regarding financial strategies and long-term vision, forecasting, and business operations. I was also responsible for overseeing several functional areas, including the business office (accounting, budgeting, cashier's office, and external audit), human resources and payroll, purchasing and receiving (procurement, leasing, contracts, credit cards, and risk management), information technology, campus police and security, and the financial operations for campus safety, government relations, auxiliary operations, and athletics.

Furthermore, I skillfully negotiated contracts with multiple unions to improve working conditions, increase compensation, and enhance performance. My unwavering focus on finding common ground between management and labor resulted in innovative solutions to complex problems.

Listed are a few of my direct accomplishments:

- » Increased reserves from \$1.1M in FY12 to \$18.7M in FY22
- » Established a new campus budget and planning committee with all stakeholders participating.
- » Presented, approved, and managed eleven straight balance budgets, and I provided the fiscal analysis and forecasts for nine of them. The NMHU's governing board approved all budgets, including the NM Higher Education Department and the NM Department of Finance and Administration.
- » Nine consecutive years of clean audits resulted in unmodified financial statements and federal awards.
- » Increased the university's overall financial indices from .012 to over 2.83
- » I prepared and lobbied for capital funding requests for NMHU over two and half decades.
- » Successfully lobbied for \$27 million (FY 2007 to FY 2024) in reoccurring funding and



\$93.6 million in capital outlay (FY 2007 to FY 2024).

- » I managed over twenty-seven capital projects and three major IT conversions.
- » I worked and collaborated with numerous governing board members. I was appointed chair of the CFO ad-hoc committee for the statewide Council of University President and presented to the NM Higher Education Regents Coalition on budgets and financial best practices.
- » The university-wide executive is responsible for government relations, including state and federal lobbying efforts, coordination, and communications.
- » We increased faculty, staff, and administration salaries by over 35% during my tenure.
- » Implement a comprehensive compensation study staff.
- » Lead negotiator for all fiscal matters for the administration with NMHU's three utterly separate bargaining units: faculty, professional staff, and non-exempt staff. I negotiated three complete, separate bargaining agreements and two ultimately brand-new collective bargaining agreements.
- » I serve on the executive capital campaign cabinet to establish priorities for NMHU's first capital campaign;
- » Worked closely with the President and vice president for Advance to secure the highest name-right gift in NMHU history, over \$1M.
- » Worked with the Provost, deans of Education, Social Work, and College of Arts and Science to secure \$20,500,000 in endowments from the state of New Mexico legislature for faculty positions;
- » Lead executive for finance for the NMHU team to meet Higher Learning Commission requirements, resulting in the removal of probation.
- » Partnered with CIOs from the University of New Mexico (UNM), New Mexican State University (NMSU), and New Mexico Tech (NMT) to establish the Western Regional Network (WRN). NMHU was the first regional comprehensive university to join UNM GigiaPoP, thus providing the rural client with a business case. NMHU has been an active member of this consortium since 2010.
- » I co-created the NMHU Legislative Leadership Fellowship Program (LLFP) to groom future leaders and professionals. I lead the LLFP program for graduate and undergraduate students, along with others. The program provides practical experience in leadership, government, and legislative processes. One of the program's activities involves lobbying for an initiative to attract and retain students on campus and requesting one-time capital outlay funds to affect such improvements. Over the past five years, the students have successfully acquired funds via the legislative process to enhance the student experience at the main campus and centers. The program boasts diverse participants who have become Student Board of Regents and Student Senate Presidents, securing statewide and national internship opportunities and admission into law school beyond the program. The program has successfully lobbied for nearly 2 million dollars.
- » I spearheaded the development of the public education budget operating for



fiscal year 2020 during the 2019 Legislative session at the New Mexico Lieutenant Governor's office. The budget allocated a revolutionary 6% pay raise for teachers and staff, marking the highest increase in decades. Additionally, we successfully funded numerous educational startup programs, including K-5, mentorship and professional development for teachers, a new Early Childhood Education and Care Department, extended learning time, a teacher pipeline, culturally and linguistically diverse materials and curricula, and funding for improved data collection and reporting. The budget totaled \$3.4 billion, reflecting an impressive increase of \$206 million or 6.4%.

» I was fortunate to be one of the founding members of the Safe Schools Summit in New Mexico. This summit offered professional development opportunities to all levels of the educational system, including public and higher education, law enforcement, local and state governments, and federal agencies. Our goal, developed with Governor Michelle Lujan Grisham and Lieutenant Governor Dr. Howie Morales, was a proactive approach to combating school shootings and, if possible, establishing a new nationwide model.
