Serving as an interim dean for the Hasan School of Business with approximately 40 faculty, 10 staff and 11 degree programs. Responsible for hiring a new permanent dean, establishing leadership programs for university wide emerging leaders, ensuring a successful accreditation and assessment process for the school, overseeing budget and enrollments, creating strong processes and policies and managing the day-to-day operations of this prestigious, AACSB accredited business school.

Provost and Vice President

Central Washington University

My responsibilities as Provost included serving as the chief academic officer for CWU, a regional comprehensive, emerging Hispanic university with approximately 9000 students and 450 faculty. My direct reports included seven deans, the executive director of the honors college, the executive director of international studies, the executive director of CWU's multimodal learning center, a vice provost, a communications director, director of faculty affairs and two staff members. The Office of the Registrar and the School of Graduate Studies and Research also report to the Provost's Office. In addition, I oversaw CWU's eight instructional sites and centers, co-located at community colleges. I was also responsible for oversight of graduation rate initiatives, retention initiatives, student success, and scheduling. Between 2020 and 2022 I oversaw the division of student success with a dean of students, and six directors. I managed a \$75 million budget, faculty evaluations for tenure, post tenure and non-tenure track promotion and renewal. As provost I worked closely with Faculty Senate and with union leadership to ensure faculty voices were heard and created a stronger, more collegial working relationship between faculty and the administration. I also focused on creating easier structures for students to navigate CWU's bureaucracy.

Student Success/Retention

- Worked with our student affairs division to redesign our new student orientation and student preview days.
- Worked with Faculty Senate, Department Chairs and Deans to raise awareness of DFW rates, gather verified data on DFW rates and began working on strategies to lower DFW rates.
- Worked with and assisted our registrar's office in applying for a WICHE grant (No Holding Back) to reduce the number of holds on student accounts and improve student retention and graduation. Supported the project and collaborated with other divisions to implement best practices around holds.
- Reorganized University Wide Advising Structure. Worked with Undergraduate Studies to create consistent advising training. Moved some advisors to the colleges to ensure seamless advising of students. Worked with the leadership team to create assessment

- structures for advising. After input from advising teams and leadership teams, implemented Civitas to assist our students and advisors with retention and advising efforts.
- Worked across university divisions to create a structure which allowed students to declare a major.
- Created an Office of Undergraduate Studies to oversee advising, mentoring, tutoring, continuing education, an Undergraduate Research Symposium, and a variety of retention efforts.
- Advocated for and received legislative funding for peer mentoring program. Assisted our advising division and undergraduate studies in implementing peer mentoring programs.
- Worked with faculty leadership to create an approved AA degree for CWU.
- Collaborated with our student success team to create appropriate student support so that
 faculty and students have necessary resources for excellence in teaching and learning.
 Under my leadership CWU increased funding and support for peer mentoring,
 supplemental instruction, and tutoring.
- Collaborated with advising teams and undergraduate studies to redesign our first-year experience course.
- Worked with faculty senate, advisors, and English and Math faculty to create selfplacements and modified placement processes for first year Math and English.

 Sustainability Fellow created a sustainability LLC and prepared our AASHE stars report,
 the Provost's Diversity Fellow worked on a social justice community day and hosted
 scholar talks, the Provost's Faculty Fellow created an alternative grading seminar for
 faculty, and the Provost's Student Success Fellow worked on DFW rates and mapping
 High Impact Practices in the curriculum.
- Developed an Equity Focused Summer High Impact Practices Institute for faculty. At the summer institute 12 faculty teams worked together with a faculty mentor to develop projects. A keynote speaker set the tone by talking about inclusive and culturally relevant high impact practices. Presentations at the institute focused on practical advice about a variety of high impact practices by experienced faculty and on diversifying high impact practices. Mentors worked with faculty on how to create sustainable projects. Projects included, a CWU Lead Together Student Leadership program, Expanding Field Based Learning Opportunities for Pre-Service STEM Teachers, and a Music Literacy Pre College-Program.
- Developed a full day Fall Faculty Conference with a keynote speaker who spoke about best practices in pedagogy for diverse students and faculty presentations about alternative grading practices, culturally responsive teaching, reducing textbook costs through open access and alternative textbook choices.
